Allocation of Radio Frequencies (1990)



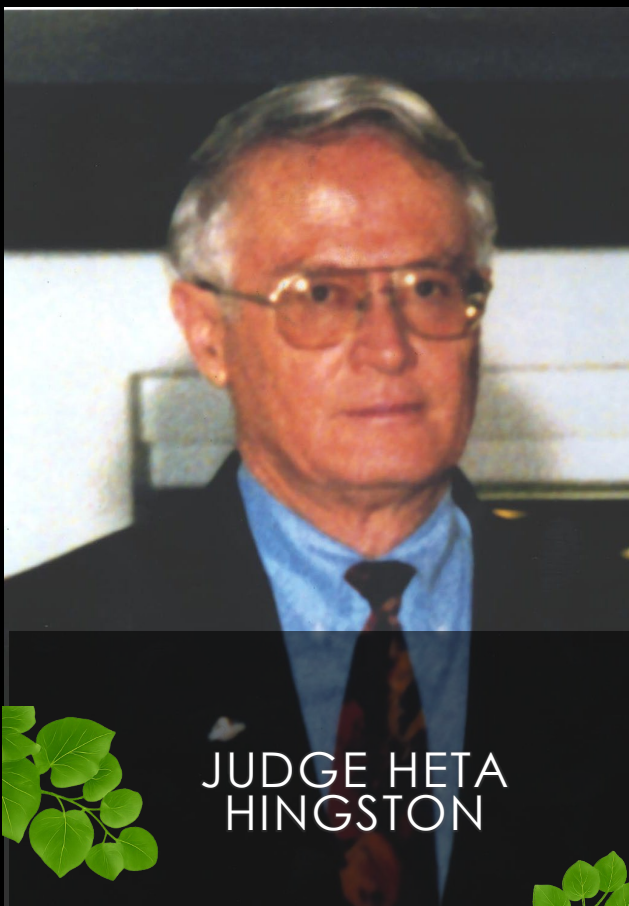
